In case the information and documents requested by our company in this application form are missing, these information and documents will be requested to be provided to our Company as soon as possible by contacting with you. The application evaluation period will cease for 30 days until these information and documents are properly provided to our Company. In this case, our Company's legal rights are reserved. Therefore, the relevant form should be sent so as to contain the requested information and documents in a complete manner according to the nature of your request.

This application form has been issued to determine your relationship with our Company and, if any, to determine your personal data processed by our Company, in order to respond to your application correctly and in legal time.
